He was expelled from his community college, but that only removed him from one setting, but his troubling behaviors didn't necessarily change nor did he leave the community.

I would like to sit down with you all (and others; I've only listed a few folks and I know there are others who should be in this conversation too) to talk about this a bit more. I think it relates directly to the grant project we're working on, but it also exposes a weakness in resources that the grant project itself cannot shore up directly. That weakness is the lack of a focal point where concerns can be shared by the public.

I know we have the police department, and our friend and colleague Cmdr. Ana Lalley from the Elgin Police Department is on this thread, and certainly law enforcement is a reporting option. However, in the many conversations I've had with people and with some of the qualitative research we've seen from around the country in the area of violence prevention more broadly, I know that people are reluctant to report things to law enforcement that are not obviously imminent or current threats.


Solutions to this kind of a problem are elusive. There are multiple tracks to pursue solutions. This is only one of them, but it is one that we have been thinking about and working on together so I thought I would put this out there for you all.

Perhaps we can do a call together to talk about it and get everyone's thoughts on this. We can certainly use this email thread to share some initial thoughts too.

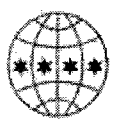
